Special Ed. input was based upon assessment of caseload made by Special Ed. admins during 20-21 school year and projected case load for the following year leading to the decision by the admin team to increase staffing for better support of Special Ed. needs in the 21-22 school year.

While committees are open to all families, they do not include targeted input specifically from tribal communities, civil rights organizations, or advocates of children with disabilities, English learners, homeless, foster youth or similar specified student communities.

Our Safety Committees and Academic Committees meet regularly, monthly or quarterly. Among the stated concerns expressed from our community members through these committees was the need to upgrade our HVAC system and implement stringent safety protocols for COVID. Student Disparity Plans were developed as a result of parent and staff input, including through the Academic Committee, and informed by trends in regular student assessments and monitoring.

## Introduction

A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

    - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.
